Dear friends in South East Derbyshire Deanery,

None of us will ever forget this year and, as we start this school year, we continue to face difficult times in our communities as the economic impact of COVID bites and Brexit draws closer. Our churches continue to face difficulties as we look to celebrating harvest, plan remembrance and think about Christmas. All of which are likely to be different and are having to be rethought in light of COVID and social distancing. This coupled with the fact that some people in our communities are ignoring guidelines, or are confused by what guidelines apply, where is putting strains of church leaders lay and ordained.

I have likened this feeling to driving a new car. All of the things you normally use are there but not quite in the same place. All the festivals and parts of church life will be part of the coming months such as harvest and APCMs but not quite in the same way. Some church buildings will not be open again this year and some will continue to do a mixture of services online and in the building. The context we are working in is different too, as people adjust to changes in their own life.

Each situation is unique, and we need to pray and care for one another as we navigate the way ahead. Sharing our ideas and listening to the insight we gain is vital as we learn afresh what it means to be a missional church. There is no doubt this experience will change us and our churches, so that when we emerge from the experience of COVID we will take with us lessons learned and new ways of doing things.

We may find ourselves over the coming months evaluating what our churches pick up and what we no longer do. Many of us have found new opportunities presenting themselves, new contacts made and new ideas for example zoom. In all of this it is vital we listening to God's prompting and guiding and also manage our expectations.

Please be assured of my prayers and support and do get in touch if we can help as a deanery in any way.

Deanery Synod elections and APCMs

Provision has now been made for APCM's to take place either in person or remotely. These will need to take place by either mean by 31st October Existing Deanery Synod members will remain in office until 30th November and remain part of their PCC until that date and new members, voted for at APCM, will take up office on 1st December. Wardens will remain in office until 31st January 2021 unless their successors (voted for at APCM) have been 'sworn in' before that date. The admission of wardens will take place via zoom and dates will be announced soon. Likewise, provision has been made via a Bishop's Instrument for Deanery Synods to take place remotely until it is safe to resume

Guidance on Holding an Annual Parish Meeting (APM) and Annual Parochial Church Meeting (APCM) whilst Covid-19 restrictions are in place

In March, Bishop Libby signed an Instrument which postponed the need to hold the APM and APCM in each parish until 31st October 2020. The deadline for holding them cannot be put back again. Some parishes will already have received e-mails from the Charity Commission, asking for their approved accounts. Churches and church halls can now be used, subject to compliance with Government restrictions. Bishop Libby has signed another Instrument, dated 17th August 2020, enabling parishes, should they wish to do so, to hold their APMs and APCMs remotely. Archdeacons will also be able to hold some or all of their Visitations remotely, too. Please remember

- The new rules about the possibility of postal voting for the APCM are not available for use this year. If you want to use them next year, you will need to pass a resolution to that effect at this year's APCM.
- There is no minimum quorum for APMs or APCMs.
- Deanery representatives should be appointed this year.
- Sidespersons are no longer appointed by the APCM but by the PCC.
- Nominations for posts will need to be re-opened prior to the meetings, be they actual or virtual.
- Face-coverings will be mandatory for attendees at a physical meeting, unless an exemption applies.
- Paperwork for the appointment of churchwardens was sent out from the Registry by e-mail on 12-13 March. If you need it again, please contact Natalie Hutchinson, the Registry Clerk, on nh@ewlaw.co.uk.

There are two options for holding APMs/APCMs:

- a) Physically or
- b) Remotely by video conferencing facility (such as Zoom)

A hybrid meeting would be possible but it is likely to prove quite difficult to manage efficiently.

Parishes are not obliged to open the church or church hall for the purpose of these meetings. If they do wish to do so, the risk assessment must show there is sufficient capacity to hold the meetings AND your Archdeacon has signed it off. **The decision on which option to use should, if possible, be a PCC decision.**

Holding a meeting at which parishioners are physically present:

1) Assess your building, be that church or church hall, by working through the most recent version of the Risk Assessment available on the Church of England website. Bear in mind that capacity isn't the only criterion which you need to consider.

- 2) Work out how many people can be accommodated within the rules of social distancing and safety. As the meetings won't class as 'life events', there is no restriction on numbers permitted to attend, but you will have to work out how many can safely be in the building at the same time. For some churches, this will be less than the 30 permitted for 'life events'; for others it will be more.
- 3) How many do you usually have at your APM/APCM? If you could comfortably accommodate that number, whilst adhering to all Government restrictions and Church of England guidance, you can go ahead and hold a physical meeting, but you don't have to.
- 4) Put up notices in the usual way, advertise it well online and in whatever way is appropriate for your parish. Please note that people attending the meetings will be expected to:
- a) wash their hands thoroughly or use the hand sanitiser provided;
- b) wear masks, unless a Government exemption applies to a particular person;
- c) give his/her name, address and telephone number for contact tracing purposes upon arrival. These details will be destroyed after 21 days.
- d) bring to the meeting relevant paperwork which will have been sent out previously to members on the Electoral Roll.

Holding a virtual meeting:

- 1) Include in the notice for the APM the ID and access code to enter the meeting. Make this a separate meeting with its own, unique ID so no-one would be able to gate-crash the APCM or, indeed, a future meeting.
- 2) Advertise it widely, as set out at 4) in the previous section on physical meetings. 3) The notice for the APCM should include the ID and access code for the separate meeting of the APCM and needs to go to all members on the electoral roll only.
- 4) If a person on the electoral roll has given you their e-mail address, you are allowed to use it for the purpose of notifying them of the APM and APCM because it is for the purposes of fulfilling your obligations under the Church Representation Rules.
- 5) Identify a host who is someone other than the Chair of the meeting and who will be in charge of the IT at the meeting. Name and give contact details of that person on the notice.
- 6) Ask that, if possible, anyone wishing to attend the APM notifies the host in advance. This may make it easier to check up in advance whether someone is entitled to attend.
- 7) You could add something along the following lines to your notice: a) If you do not have internet access and would like to attend, please contact (name the host) who will see what can be done to assist by way of telephone link. b) For those who are hard of hearing, there may be a facility to include live captions. If this would help you to participate more fully, then please contact (name host) in advance of the meeting.
- 8) The host of the meeting shouldn't be the Chair but should be someone whose task it is to vet and admit people wanting to attend and checking the eligibility of anyone they don't know. They also need to be able to silence or remove anyone causing unnecessary disruption.
- 9) It would be sensible for the host and the Chair to be in contact by text or similar as appropriate. The Chair should likewise be in contact with anyone with whom they might want a private word during the meeting.
- 10) There is the facility on some meeting providers for those without internet access to link in by Telephone and Computer Audio and to have live captions (though be aware that you may need to pay for this option) of what is being said for those hard of hearing.
- 11) If you are proposing to record one or both of the meetings (which may be helpful from the point of view of taking the minutes), make sure that you notify everyone both in the notices and at the beginning of each meeting that this is what will be happening. Say that the recording will be deleted after 21 days and make sure that is done.

DEANERY SYNODS

PROVISION MADE BY THE BISHOP OF DERBY UNDER CHURCH REPRESENTATION RULES 2020

This Instrument is made on twenty-fifth August 2020 and has effect within the Diocese of Derby from the date on which it is made until thirty-first August 2021 or until revoked if sooner During this period a deanery synod ('the Synod') may hold any of its meetings remotely should it wish to do so

Remote working

- 1. Rule 26 Church Representation Rules 2020 (procedure of deanery synods) and the Rules for Deanery Synods dated 10th June 2017 apply with the following modifications.
- 2. A reference to a meeting of the Synod includes a reference to a meeting which persons may attend, speak at, vote in, or otherwise participate in without all of the persons, or without any of the persons, being together in the same place.
- 3. •A reference to a place where a meeting of the Synod is held, or is to be held, includes a reference to more than one place, including electronic, digital or virtual locations, web addresses or conference call telephone numbers.
- 4. A person is to be regarded as present at a meeting of the Synod at any given time if the person is at that time able to hear and be heard and, where practicable, see and be seen by the other persons present.
- 5. A vote, whether of the whole Synod or by Houses, may be taken by such electronic method of voting as may be determined by the Area Dean (or, if the post is vacant, by the Acting Area Dean) and the Chair of the House of Laity of the Synod, acting jointly.
- 6. The provisions made by this Instrument have effect in spite of any inconsistent provision in any Rule of the Synod and any such provision is to be ignored.
- 7. A reference in this Instrument to being present at a meeting of the Synod includes a reference to being present by electronic means, including by telephone conference, video conference, live webcast and live interactive streaming.

The Independent Examiner

One of the formalities of the Annual Parochial Church Meeting is the appointment of the Independent Examiner [IE]. So, who can be appointed and what is their role? The first thing to say is that if the PCC's annual turnover exceeds £250,000 or its accounts are prepared on an accruals basis then you need a qualified accountant or auditor as your IE. As I suspect few if any of our churches are in that position these notes only apply to PCCs with turnover of under £250000, with accounts prepared on a receipts and payments basis.

The IE does not have to hold any formal qualifications, just a working knowledge of financial matters.

The IE should not be a member of the PCC, employed by the PCC or in any way connected to anyone who is. It can be a member of the congregation but it is easier to demonstrate complete independence if it is someone who is not connected to the church. Perhaps have an arrangement with a neighbouring parish to cover each other's examination.

The IE has to be appointed at the APCM but this is usually on the recommendation of the PCC who should consider the suitability of their nominee. An IE may be prepared to do the examination for free or a small charitable donation. As mentioned, a quid pro quo arrangement with another church could be arranged. If all else fails, you will need to pay a fee. The IE should not be expected to prepare accounts, they just examine accounts prepared by the treasurer against the ledgers maintained by the treasures and bank and investment statements.

The IE should

- Check that the balances agree with bank statements, investment reports and any cash book
- Identify any significant items reflected in those statements and seek documentary evidence of the purpose of the receipt or payments and how they have been reflected in the accounts
- Randomly review other entries and check against supporting evidence concentrate on irregular or fluctuating items
- Pay particular attention to payments made to PCC members, employees or connected persons.
- Once satisfied complete the certificate. Certificate 4.2 in this guidance

Welcome on Wednesday

Welcome on Wednesday (WOW) has been a community lunch at St John's Church, Long Eaton that has run for the last 3 years and when lock down came we all cried when we had to shut. We had built up a really good community and feed a lot of people. After the first shock of lock down the PCC and I started to talk about our lock down exit plan and what small steps we wanted to take towards that. WOW, it was decided, was the first thing to get up and running and so with a lot of planning, risk assessments and permission from the Bishop we re-opened after 8 weeks of lockdown as a take away from the door of the hall serving a hot meal. Our local councillor gave us some money for takeaway containers and we were supplied with food through the feeding Derbyshire network. It is different and not the same and we took a number of weeks to get the hang of it – like having only a few volunteers in and training people to use the line and waiting system but gradually the community has returned. We are feeding around 80 to 90 people a week and offering foodbank vouchers, CAB signposting and help with universal credit claims. It feels good to be back. One delight of it all has been working across churches in the area, including Tony Street and Elaine Jones from Sawley, in a way we hadn't before and friendships have been formed and developed for future working. We have no plans to return inside at the moment because of restrictions – we aren't prepared to choose who can eat and most people who come have no internet connection or mobile phone credit to book places. Season of Creation - 2020


Creationtide or the Season of Creation is

Virtual Retreats

Leading retreats are something I have done for many years and I have lead an annual Advent retreat for Cliff College in Derbyshire for last 6 years. I do really enjoy the thinking, praying and preparing for a retreat and I love the extra time you get to go deep with people in a way you don't get on a Sunday morning. During lock down I had been working on my tech skills for online services and I also did a range of online courses that suddenly become available so I wondered on Facebook if anyone fancied trying an online retreat and they did. So I created a private Facebook group for the retreat and got planning. I wrote and recorded three talks, prepared questions and activities and loaded them on the group. 90 people signed up and took part over 2 days (the same retreat twice) with optional zoom prayer morning and evening and booked in messenger chats with people. Those on retreat created a space in their homes and worked through the videos and activities at their own pace – sharing creative activities online afterwards. I really enjoyed running the retreat and managed to connect with friends in Finland and Moscow for the retreat. As we learn more about faith at home and encourage people in that this seems like a very accessible way forward. The next retreat is early September and this will be repeated in October with an Advent one planned for late November. Do contact me if you would like to take part. Sam Tredwell
