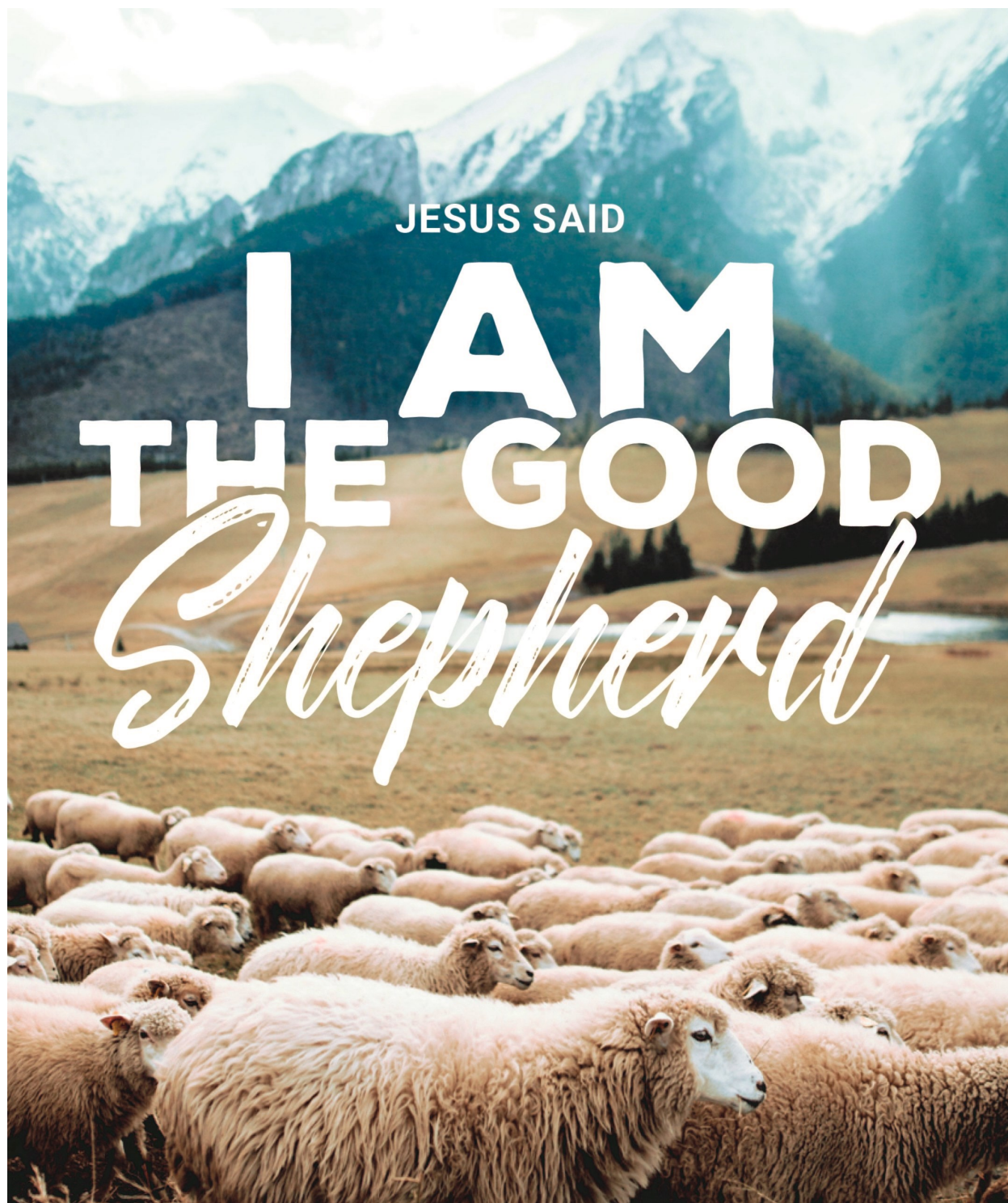

From the Deanery Team ..

I was recently asked, by those responsible for the job specification for the new Archdeacon, about the mission focus of South East Derbyshire. Well, we are made up of a number of different churches and communities that have different ways of mission outreach. However, I did talk about the amount of social outreach connected to many of our churches: foodbanks, community cafes, supporting the vulnerable and it goes on. Some are directly run by our churches; others are ecumenical projects and others are ones that our churches support through finance or volunteering. At our recent Deanery Synod, we heard about one project for the homeless that was expanding its support. Although the Canaan Trust is based in Long Eaton, there was a commitment to support people in risk of homelessness throughout our Deanery. There is a flyer later in the newsletter about their 'sleep out'. Whilst this is a fund raiser it also seeks to highlight the problems of homelessness. At the time of writing the political focus is very much on international events so other political initiatives are taking a back seat but there is much to be done to address the structures in society that leave so many in need of our support. So, whilst it is good seek to address these structural issues [something where 'Church Action on Poverty' are particularly active] let's not give up on those small acts of kindness that bring a feeling of Christ's love in the hearts of those in need.

Another area where, as the Lay Chair, I hope the new Archdeacon will be active is around the empowerment of lay ministry which is very much part of the Diocesan Vision. Every aspect of church life, including the social outreach, relies on the unstinting support of church members. If we are expected to be providing an even greater level of leadership to supplement the work of our clergy, we need support, clarity of roles and a lot of encouragement.

Related to the work of the laity there are two roles within the Deanery that need filling and are detailed on the next page. Neither role is that onerous and also gives the role holder an opportunity to contribute to our mission across the deanery through membership of the Deanery leadership Team. Please consider these two posts.

Deanery Secretary

Following the retirement of John Puxty we are looking to fill the post of Deanery Secretary. The Secretary is formally responsible for any elections that have to be held amongst Deanery Synod members in relation to the Deanery, Diocesan and General Synods. He/she in theory is responsible for arranging Deanery Synods and Deanery Leadership Team meetings, including sorting the venue, speaker and agenda, and taking minutes. However, all these duties are currently undertaken by the Deanery Administrator. The Deanery Secretary takes a full role in the work of the Leadership Team.

Deanery Treasurer

When Sydney Leleux was appointed as our Deanery Treasurer, he made it clear that it was only a temporary offer of help. Sydney has taken great strides in updating our banking arrangements so the new post-holder should have a reasonably clear run at managing our finances. The Deanery treasurer takes a full role in the work of the Deanery Leadership Team.

Diocesan Synod Representative

We also need to choose 2 new Diocesan Synod representatives in light of John's retirement and a further resignation. Please do consider if this is something you feel called to do.

Deanery Announcements

The **Revd Tracy Robinson**, Chaplain to Derby Teaching Hospitals NHS Foundation Trust, Diocese of Derby, has been appointed Priest-in-Charge of the Derby Group. Her licensing will be announced in due course.

The **Revd Julius Anozie**, Assistant Curate of Ilkeston St Mary and of Ilkeston St John, Diocese of Derby, will transfer his curacy and become Assistant Curate of Kirk Hallam.

The **Revd Pam Macnaughton**, Leadership Enabler for CPAS, has been appointed Assistant Curate (SSM-known as Associate Priest) of Ripley, Diocese of Derby. Revd Macnaughton was licensed on Sunday, 27 February 2022 at All Saints Ripley by the Bishop of Derby, assisted by the Acting Archdeacon of Derby.

Bishops in solidarity with Ukraine

The Rt Revd Libby Lane, Bishop of Derby, and the Rt Revd Malcolm Macnaughton, Bishop of Repton, stand with the Archbishops of Canterbury and York in condemning the invasion of Ukraine and calling for prayers for all those affected.

In a joint statement, the archbishops said: "The horrific and unprovoked attack on Ukraine is an act of great evil. "Placing our trust in Jesus Christ, the author of peace, we pray for an urgent ceasefire and a withdrawal of Russian forces. "We call for a public decision to choose the way of peace and an international conference to secure long term agreements for stability and lasting peace."

Annual Parochial Church Meetings and Electoral Rolls 2022

Elections of Wardens and PCC members should take place by 31st May 2022. This year, electoral rolls should be updated as necessary, but a new roll is not required. Details of what is required of PCC's and the duty of the electoral roll officer can be found at [Electoral Roll - Diocese of Derby \(anglican.org\)](https://www.anglican.org/electoral-roll)

This year there is the opportunity to fill any vacant parish places on Deanery Synod but current members remain in post until 2023. It is important that any changes to Synod members are recorded and details passed to the Deanery Administrator and Diocese.

There are forms which should be used for both the electoral roll and for those wishing to stand as members of PCC, Deanery Synod or as church wardens on the Derby Diocese website at [Governance - Diocese of Derby \(anglican.org\)](https://www.anglican.org/governance).

Candidates need to fill in a declaration that they are a 'fit and proper person' in respect of financial requirements as trustees under the rules of the Charity Commission. This also applies to fees officers and gift aid secretaries if they are not PCC members.

The declaration will also require a statement that the candidate is not barred under the DBS safeguarding rules. Upon appointment all PCC members should undertake an enhanced DBS check, if they do not already have one from the Diocese.

Parish Finance Returns

Incumbents, wardens, or treasurers in each parish will have access to the Parish Returns site within the C of E Portal and **need to enter financial information for 2021 online.**

The portal is now open, and information should be submitted of the audited financial report has been passed by PCC. A copy of the report should also be sent to the Diocese and Area Dean preferably by email. **This should be done by 18th June, if at all possible.**

Reports can be entered prior to APCM if necessary.

Treasurers with queries please contact Amanda, Deanery Administrator, who is overseeing the return for the Deanery who will seek information as to what process to follow. She is happy to assist with the process for those who need help with the technology or to add new names to list of those able to access the site in your parish or issue new login and passwords if they have been forgotten!

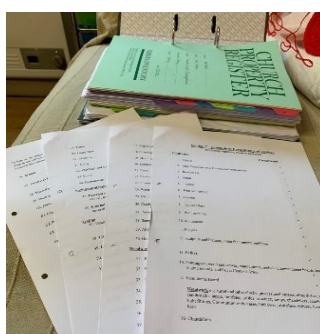
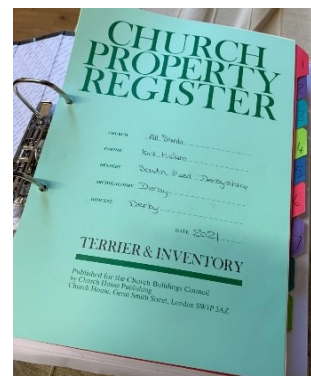

If you are thinking it's time your Terrier was up-dated, then she is only too willing to chat and share the resources generated, including for Section 7 the 68 different sub-categories!

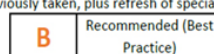
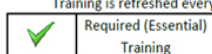

Rebuilding Lives

In February, the Deanery Synod were pleased to welcome Kevin Curtis from The Canaan Trust as their speaker.

The Canaan Trust is an independent Christian Charity which provides safe secure and healthy supported accommodation for homeless males aged 16-54. Based in Long Eaton, Nottingham the Trust serves the needs of homeless men from Long Eaton, Ilkeston, Sandiacre, Stapleford, Sawley, Cotmanhay, Beeston, Chilwell, and Toton – all parts of Derbyshire and Nottinghamshire. They also support females and families.

Person Centred in its approach the Canaan Trust values every homeless person as a unique individual. The Trust is committed to transparency, to fair access, diversity, inclusion as well as fair exit from its service.

The Canaan Trust supplies accommodation as the tip of the iceberg of its homeless service. Staff provide individual and collective support 24-7 with staff permanently, physically, available on site, recognizing that the homeless have complex needs which have contributed to their homelessness and they subsequent social exclusion.

The Trust will be holding its annual SLEEP OUT on Friday 22nd April. The SLEEP OUT will commence at 8pm on the Friday night and end at 7am on the Saturday morning. Report of General Synod 8-10 February 2022

General Synod gathered in Westminster for its second session of this quinquennium on 8-10 February 2022.

The group of Derby representatives (including one member who attended online) spoke at a number of the debates and submitted questions to the question session. I gave my maiden speech at the debate on God's people set free.



Alongside general business and appointments to offices on the Synod, the session heard, debated and voted on a variety of issues concerning both the specific activities of the Church in England and matters of justice in the wider world.

Racial Justice: Introduction to the Archbishops' Racial Justice Commission, and update to Synod on racial justice work.

The report *From Lament to Action* published last year led to the setting up of the Archbishops' Commission for Racial Justice, chaired by Lord Paul Boateng.

Lord Boateng delivered a powerful speech laying out how there is so much more to be done both in and outside the church. The Commission will report further on its work at its website, where you can find more information.

Safeguarding

An item on safeguarding included information about work being undertaken by the National Safeguarding Team and Lead Bishops for Safeguarding. General Synod members were invited to take note of the workstreams and projects that are set out in this paper.

Dame Maggie Atkinson, chair of the Independent Safeguarding Board spoke about the Board's work so far which led to a discussion about the governance and the fact that although the Board has identified some areas that need to be strengthened, they do not have the power to do so.

Faculty Jurisdiction (Amendment) Rules 2022

The Faculty Jurisdiction (Amendment) Rules 2022 was about amendments to how changes to church buildings are undertaken which will help the CofE become carbon neutral by 2030.

Changes to the faculty jurisdiction rules - the Church's equivalent of planning law -

were proposed to ensure that the rules work in step with churches trying to reach net zero carbon. Nearly all the changes will make it easier for churches to make environmentally-friendly adaptations (see a summary of the changes on [page 7 of the Synod paper here](#)).

The amendments included one requiring that replacement of oil and gas boilers, and the replacement of oil tanks, will need a faculty application once the revised rules come into effect later this year. This was the most controversial of the proposals and an amendment was proposed to remove this requirement, but the argument was made that seeking a faculty would mean that those replacing the boiler would get advice about non fossil fuel alternatives.

All the amendments to the rules were passed and it will be helpful for PCCs to be made aware. Parishes will want to plan ahead and consider their options (see the [heating guidance](#) and [heating webinars](#) for help with this).

Challenging slavery and human trafficking.

In an item which will be of particular interest in Derby diocese, a pioneer in challenging slavery and human trafficking, the Synod passed the motion that they:

a) acknowledge the leading role that Her Majesty's Government has played internationally in challenging slavery; and

b) ask Her Majesty's Government to introduce legislation to ensure proper provision for the ongoing support and protection of trafficked minors is enshrined in law.

There is particular concern about new proposed legislation – the Police Crime Sentencing and Courts Bill. The Lords Spiritual have supported amendments to this that would create a statutory definition of Child Criminal Exploitation.

The National and Borders Bill is progressing through the House of Lords and it is thought changes in it would mean that children might miss a new deadline for providing information about their exploitation and also that support would be denied to anyone who has committed serious crimes as those trafficked are often involved in criminal activity such as drug trafficking and prostitution. Section (b) of the motion aims to challenge this.

Report of the Review of Clergy Remuneration

Report by the Governance Review Group

The motion was:

That this Synod:

- a. Welcome the Report of the Governance Review Group (GS 2249);*
- b. Invite the Archbishops' Council and the Church Commissioners to engage with stakeholders in the Church and State on the Report's recommendations; and*
- c. invite the Archbishops' Council, in the light of the outcome of that engagement, to introduce legislation for consideration*

This is a report following an earlier paper at the November Synod about potential changes to the church's governing structures. This is not at decision point yet – the report just asked for Synod to welcome the original report and invite further engagement. Synod 'thanked' rather than 'welcomed' the report.

Persecuted Church in the World

The motion was:

That this Synod request that:

- a. the Church of England not only prays for the persecuted church, but that its dioceses offer support to link dioceses where the church is facing persecution, and*
- b. the next Lambeth Conference addresses the issue of the persecution of Christians.*

The Synod passed the motion and there was a general hope that parishes would be encouraged to inform themselves and to pray for the persecuted church. Sarah Tupling, a member of the Derby group and a representative of the deaf church, spoke about support offered to our link diocese in North India.
